



## THE CHLORINATOR POOL SERVICE & REPAIRS

### EQUIPMENT SWEEPSTAKES

#### OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

#### 1. SPONSOR

This Sweepstakes is sponsored by:

#### 2. ELIGIBILITY

The Chlorinator Equipment Sweepstakes ("Sweepstakes") is open only to:

- Legal residents of the State of California
- Eighteen (18) years of age or older at time of entry
- Residential swimming pool owners located within Sponsor's active service area

Employees, contractors, and immediate family members of Sponsor are not eligible to participate.

Void outside California and where prohibited by law.

### **3. ENTRY PERIOD**

The Sweepstakes begins on March 01, 2026 and continues on an ongoing basis unless terminated by Sponsor.

Drawings will initially occur **monthly**. As Sponsor's active client base increases, drawings may transition to **bi-weekly or weekly** at Sponsor's sole discretion.

Sponsor reserves the right to modify the frequency of drawings at any time.

### **4. HOW TO ENTER**

#### **Automatic Entry (Service Clients)**

Individuals who enter into an active 24-month service agreement with Sponsor during a drawing period will automatically receive one (1) entry into that drawing period. And continue to receive (1) entry into every drawing while the sweepstakes. Clients are automatically removed from further sweepstakes if they have won.

Service clients must remain in good standing (no past-due balances) at the time of drawing to remain eligible.

#### **Alternate Method of Entry (No Purchase Necessary)**

To enter without purchasing services, mail a handwritten 3"x5" card including:

- Phone Number
- Email Address

## 5. ODDS OF WINNING

Odds of winning depend on the total number of eligible entries received during each drawing period.

## 6. PRIZE DESCRIPTION

Each drawing winner will receive:

- One (1) new pool pump
- One (1) new pool filter
- Standard professional installation

Equipment brand, manufacturer, and model are selected at Sponsor's sole discretion.

Prize is:

- Non-transferable
- Not redeemable for cash
- Subject to equipment compatibility

Installation includes standard replacement only. Any additional plumbing modifications, electrical upgrades, code compliance corrections, or structural adjustments required for installation are not included and may result in additional charges.

---

## 7. WINNER SELECTION & NOTIFICATION

Winners will be selected in a random drawing from all eligible entries received during the applicable drawing period.

Winner will be notified via phone and/or email within a reasonable timeframe following the drawing.

If a selected winner:

- Cannot be contacted within seven (7) days
- Fails to meet eligibility requirements
- Refuses the prize

An alternate winner may be selected.

---

## **8. WINNER REQUIREMENTS**

Winner must:

- Provide proof of identity and California residency
- Provide proof of pool ownership at the listed residence
- Sign a liability and publicity release (where permitted by law)
- Allow reasonable scheduling for installation

Failure to complete required documentation may result in forfeiture of prize.

## **9. SERVICE AGREEMENT DISCLOSURE**

Participation in the Sweepstakes does not require entering into a service agreement.

However, individuals who voluntarily enter into a 24-month service agreement remain subject to the terms of that service contract, including any early termination provisions contained therein.

Mail-in entrants who are not service clients are not subject to service agreement obligations.

---

## **10. PUBLICITY RELEASE**

Except where prohibited by law, acceptance of prize constitutes winner's consent to Sponsor's use of winner's name, city, and likeness for promotional purposes without additional compensation.

## **11. GENERAL CONDITIONS**

Sponsor reserves the right to:

- Disqualify any entrant who tampers with the entry process
- Cancel, suspend, or modify the Sweepstakes if fraud, technical failures, or other factors impair its integrity
- Verify eligibility at any time

Sponsor's decisions are final and binding in all matters relating to the Sweepstakes.

By entering, participants agree to release and hold harmless Sponsor from any claims, damages, losses, or injuries arising out of participation in the Sweepstakes or acceptance, installation, or use of the prize.

- Lost, late, misdirected, or incomplete entries
- Equipment manufacturer defects
- Installation delays due to supply chain issues, weather, or circumstances beyond Sponsor's control

## 13. DISPUTES & GOVERNING LAW

This Sweepstakes is governed by the laws of the State of California.

Any disputes arising under these Official Rules shall be resolved exclusively in a court of competent jurisdiction located in the county of Sponsor's principal place of business.

The prevailing party in any action shall be entitled to recover reasonable attorney's fees and court costs.

Information collected from entrants is used solely for Sweepstakes administration and in accordance with Sponsor's privacy practices.
